Ques: Tell the Court your relationship with the Claimant.

Ans: I am the President.

Ques: Do you know the Defendant.

Ans: Yes

Ques: Tell the Court what transpired between your company and the defendant.

Ans: On 21/5/2019, in the afternoon, the Defendant came back to our office pleaded that he is just from the Market that the materials he intended to buy to complete the Job, that the money he collected in the morning will not be enough for him. He said we should give him another loan of №1M. Through our interrogation with him, he presented a lot of facts, that the loan will be okay for him to complete the Job in the next 9 days that he will come and settle all the loan. He went ahead and presented a payment schedule which was done by the

person who gave him contract and we told him that it is not our business. After discussing with him; he agreed with the terms and condition and we gave him another empowerment application form to file which he did and a sanction advice signed by the guarantor and we gave him the loan. The Defendant disappeared, we have not set eyes on him again. We started calling him, his response was not......He moved to a Family house at Nsirimo Ubakala. We met the Defendants father who is the custodian of the two jeeps ie the collateral. He said he is aware of the transaction and we left. In view of the whole situation, we advice our Lawyer to write him. Our Lawyer wrote him.

Ques: How much are you claiming from the Defendant.

Ans: At 44 Months of the duration of the loan, it is ₦3,953,000.00 (Three Million Nine Hundred and Fifty Three Thousand) plus the principal of the ₦1M that is a total of ₦4,953,000.00 (Four Million Nine hundred and fifty three Million). Since then, he has not paid anything.
