COURT: Judgment

The Claimant is claiming – (a) The sum of **₦1,500,000.00 (One Million Five Hundred Thousand Naira)** from the Defendants as debt owed; (b) **₦2,100.00 (Two Thousand One Hundred Naira)** as Court fee and (c) The sum of **₦100,000.00 (One Hundred Thousand Naira)** as cost.

The Claim was filed on the 8/10/2024 and same was served on the Defendants. Plea was taken on the 17/10/2024 and all the Defendant except the 2nd Defendant pleaded not liable to the 1st arm of the Claimants claim, while the 3rd Defendant

pleaded liable to the 2nd arm of the Claim. The matter was adjourned for report and Judgment.

The 2nd Defendant having admitted the Claim of the Claimant and has gone a step further in paying to the Claimant the sum of **₦1,000,000.00 (One Million Naira)** leaving a balance of **₦500,000.00 (Five Hundred Thousand Naira)**. Parties have agreed to the terms and model of liquidating the balance of the said **₦500,000.00 (Five Hundred Thousand Naira)** and the terms agreed by parties is and hereby adopted as the Judgment in this suit.

It is and hereby ordered that the 2nd defendant shall pay to the Claimant the sum of **₦500,000.00** on or before the 31st day of May, 2025. The cost of **₦100,000.00 (One Hundred Thousand Naira)** is also awarded against the 2nd defendant and the 2nd defendant shall also pay the Court fee of **₦2,100.00 (Two Thousand One Hundred Naira)**. The 3rd Defendant shall pay the Court fee of **₦2,100 (Two Thousand One Hundred Naira)** forthwith. The 1st, 3rd, 4th, 5th, 6th and 7th Defendant are hereby discharge from any liability. This is the Judgment of the Court.
