MATTER IS FOR HEARING.

Evidence of the Claimant/Attorney. Attorney affirms and states in English Language. I am Nelson O. Okereke Esq. A legal practitioner with office at No. 142 Market Road Aba. We are claiming from the Defendant the sum of ₦209,790.00 (*Two Hundred and Nine Thousand, Seven Hundred and Ninety Naira*) of debt accrued from loan advanced to the Defendant by the Umuakpa Multipurpose Co-Operative Society Ltd. The Defendant has paid the Claimant the sum of ₦101,000.00 (*One Hundred and One Thousand Naira*) to liquidate the said debt remaining the balance sum of ₦98.790.00 (*Ninety Eight Thousand, Seven Hundred and Ninety Naira*). That is all.

JUDGMENT.

Claimant claims from the Defendant the liquidated sum of ₦209,790.00 (*Two Hundred and Nine Thousand, Seven Hundred and Ninety Naira*) being of debt accrued from a loan facility advanced to the Defendant as stated in the Claimant Letter of Demand. Claimant by its Attorney testified in Court that the Defendant had liquidated to the Claimant so far the sum of ₦101,000.00 (*One Hundred and One Thousand Naira*) remaining the balance of the sum of ₦98.790.00 (*Ninety Eight Thousand, Seven Hundred and Ninety Naira*). Defendant did not file a Defence/Counter Claim. In the circumstance, Claimant by Attorney has proved its Claim and Judgment is hereby entered for the Claimant against the Defendant and the Defendant is to pay or liquidate forthwith to the Claimant the sum of ₦98.790.00 (*Ninety Eight Thousand, Seven Hundred and Ninety Naira*). There is no Order as to cost.
